### 4. FIRST AID MEASURES

### SMALL SPILLS

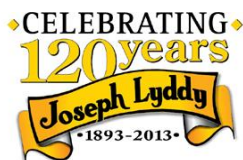

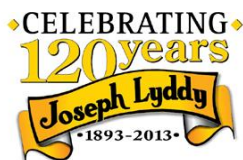
